Legislative Update



As the South Carolina General Assembly prepares to convene for the 2008 Legislative Session in January, the SC Child Care Association also needs to prepare for legislators to consider a number of issues critical to the child care industry.

The one overriding issue that will carry over from the 2007 session is the possibility of replicating the Four-year-old Kindergarten (4-K) pilot program to counties statewide. After significant negotiations, the SCCCA was comfortable with the legislation approved by the House in early 2007 and supportive of the bill so long as amendments did not create an unlevel playing field for private providers. Opponents of the school choice movement, however, were fearful that the 4-K bill could be a vehicle for the controversial "Put Parents in Charge" voucher proposal and, in a preemptive effort, voted to send the bill to the Ways and Means Committee for "further review" of its financial implications. There has been no further discussion of the bill since then, but there is a concerted effort from child advocate groups and others to bring it back up for debate early in the new session.

Two critical components of a likely 4-K debate will include a report of the results of the pilot program from the Education Oversight Committee and the costs associated with maintaining or expanding the program in what is almost certain to be a belt-tightening budget year. Many child advocates and members of the larger business community are becoming very vocal in their support for a public-private 4-K initiative, citing it as a worthy early intervention measure that will help improve the state's unsatisfactory High School graduation rate. And while they claim the increased costs will be recouped many times over in long-term savings due to the larger societal costs associated with High School drop-outs, legislators will still be faced with an estimated price tag of





With many existing priorities, a new program of that cost and magnitude will be a difficult pill for legislators to swallow in an election year plagued by a budget shortfall anticipated to be as high as \$430 Million. That said, Legislators are painfully aware of Judge Cooper's ruling on the school funding equity law suit and the requirement that the state's needlest children be prepared to enter school ready to learn.

In addition to the 4-K debate, the SCCCA should be prepared to go proactive for the first time in a number of years, working in support of two important legislative initiatives. The first, H. 4090, introduced by Representative Nikki Haley (R-Lexington) seeks to expand the definition of child care facilities, effectively placing the same licensing requirements on 4-hour child care initiatives, such as after school programs or Karate Schools, that full-day providers must meet. This bill would require such programs to become licensed with the Department of Social Services, have employees undergo SLED background checks, and meet the safety and health requirements to which child care centers are held.

SCCCA believes it is critically important that the laws of our state are upgraded to protect the health and safety of children as parents continue to seek a variety of child care arrangements that meet their changing needs. Sadly, without appropriate protections, unlicensed facilities that are not required to perform background checks and take other similar precautions are easy targets for child predators and open the door to potentially dangerous situations in the very places where parents trust that their children are safe.

The second effort comes in response to the tragic deaths of children in two unlicensed and chronically troubled child care facilities last spring. session, SCCCA will encourage the General Assembly to consider a bill making it a felony to knowingly and willfully operate a child care facility without a license. The proposed legislation would also significantly stiffen the penalties for owners or operators should a serious injury or death of a child occur at an unlawfully unlicensed child care center. While the vast majority of child care providers go to great lengths to ensure safe, healthy and nurturing environments for the children in their care, this legislation seeks to provide additional help to the Department of Social Services as they address the few bad actors that scoff at the law and refuse to comply with even minimal licensing and regulatory protections. Look for more information on both of these important efforts in the weeks and months ahead.

Finally, we are extremely proud that Shannon Erickson, now the immediate past-President of the SCCCA, has been elected as one of the newest members of the SC House of Representatives. Shannon won a hard-fought battle to represent House District 124, filling the unexpired term of now-Senator Catherine Ceips, who replaced Senator Richardson when he was appointed Commissioner of Insurance. As a child care provider, small business owner, parent, and community activist (and all around great person!!), Shannon is well prepared to serve Beaufort County and the state of South Carolina as a member of our General Assembly. And while she will have a lot to learn as a new legislator - and much more on her plate than just child care issues – it will be great to have an advocate in the House who can address first hand the challenges and opportunities facing the child care industry South Carolina. in Congratulations and Best Wishes Representative Erickson.

Editorial from Representative Shannon Erickson: As House District 124's Representative, I was asked to visit the Beaufort Marine Institute recently. I was assigned two young men to take me on a tour of the camp. The conversation with one of them was the highlight of my day. You see BMI is a "boot camp" of sorts for boys ages 13 to 17 who have been given this last chance to change their ways. My tour guide was very articulate, told me he loved school and cooking, but offered freely that he had anger issues. He explained to me that in this "boot camp" you started with the lowest rank and moved up as you met goals that you and your counselors set. What he admitted to me shyly was that he was still at the lowest rank, because of what he termed "set-backs." He went on to say that he had advanced only to have situations arise that pushed him back, but that he felt he had turned a corner this past week and had his emotions much more in control. I listened intently, wondering if these words for my benefit, but hopeful for him that it was the real thing. We finished the tour of the camp and went our separate ways -- me to chat with the director and her advisory board and he to participate in the field day activities. A short while later, I overheard a counselor calling his name and asking him to come away from the tug-of-war, my ears perked up and I watched from afar as she curtly told him he could not participate due to a wrist injury earlier that week. He was visibly upset, with his mouth in a deep, furrowed frown, and arms hanging but fists clinched. I could not turn away, and as I watched, he told the counselor in a quiet voice "alright" then moved to the side. What I witnessed made me smile...he had turned those fists into counting fingers. He was silently counting to 10, utilizing a very simple strategy for working through his anger. He sat on a tree stump and watched his team win the battle, and I thought how he had definitely won one for himself.

Now, when you have a down and dirty day, don't hang your head. Think of children like this who are struggling to take their lives back. Use the strategies & resources available to you and keep trying!

P. S. They do in-depth profiles on these young men, but have not been asking about any early education & care....guess what....they are now. I'll keep you posted on that data.
